



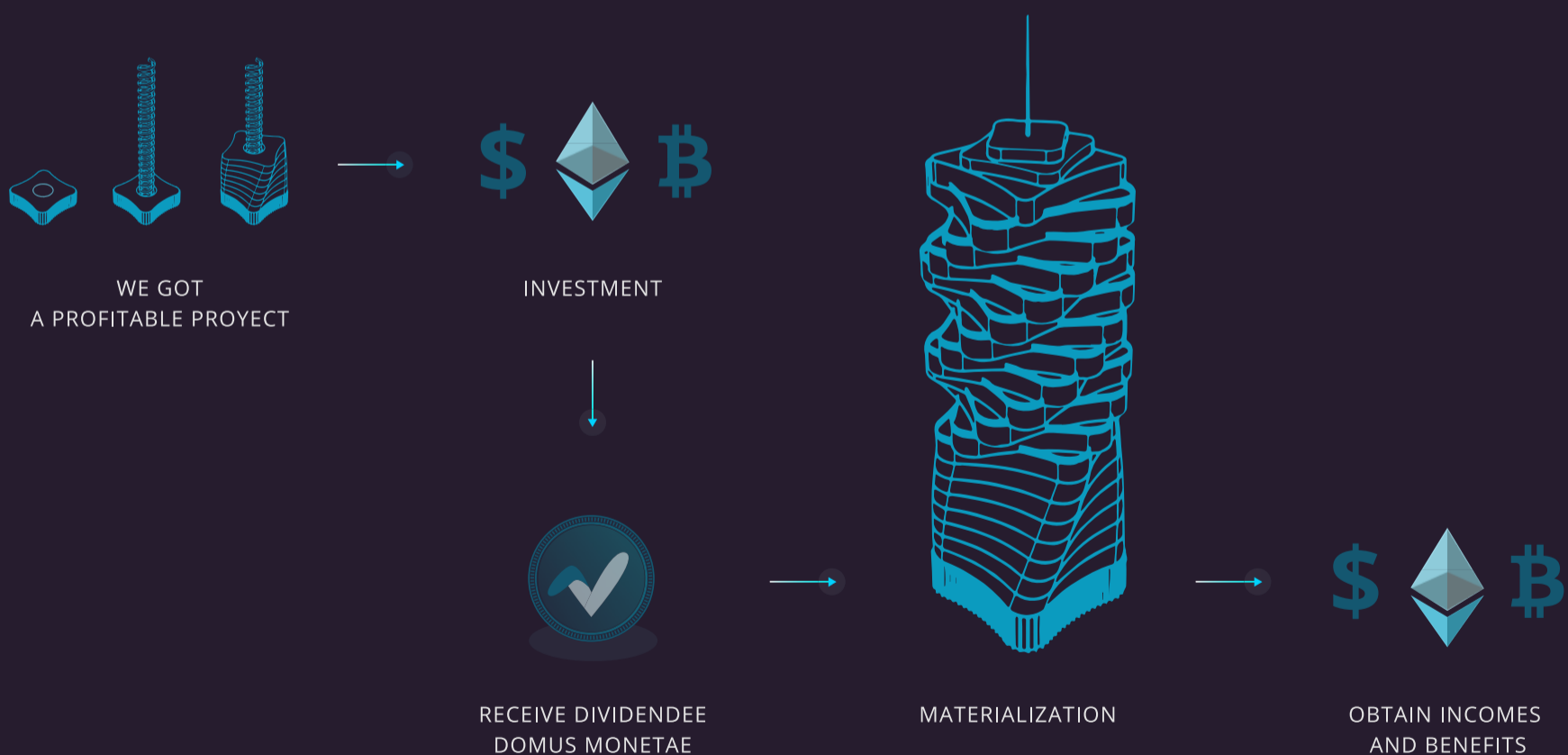

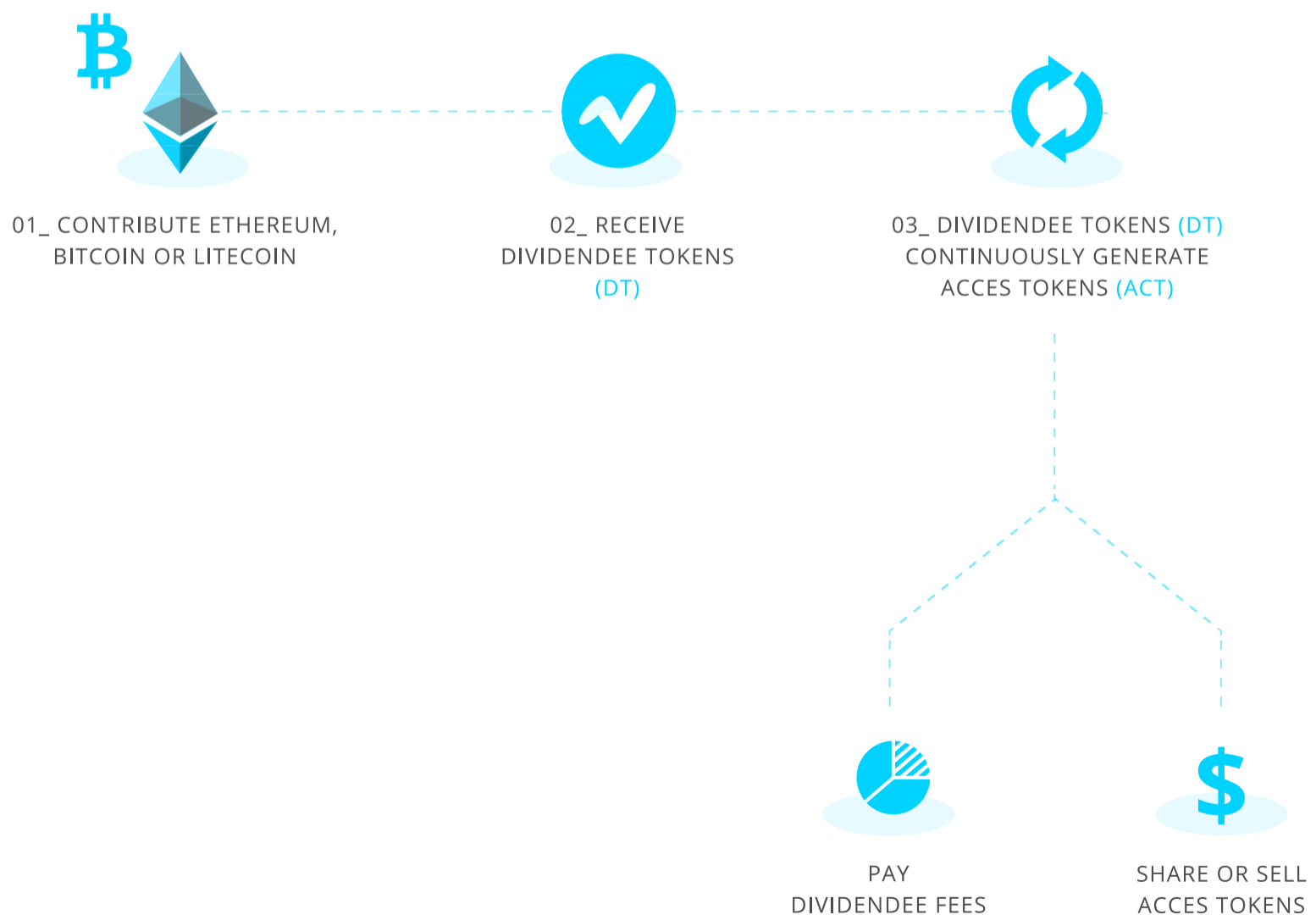
CHANGE THE COURSE OF YOUR ECONOMY

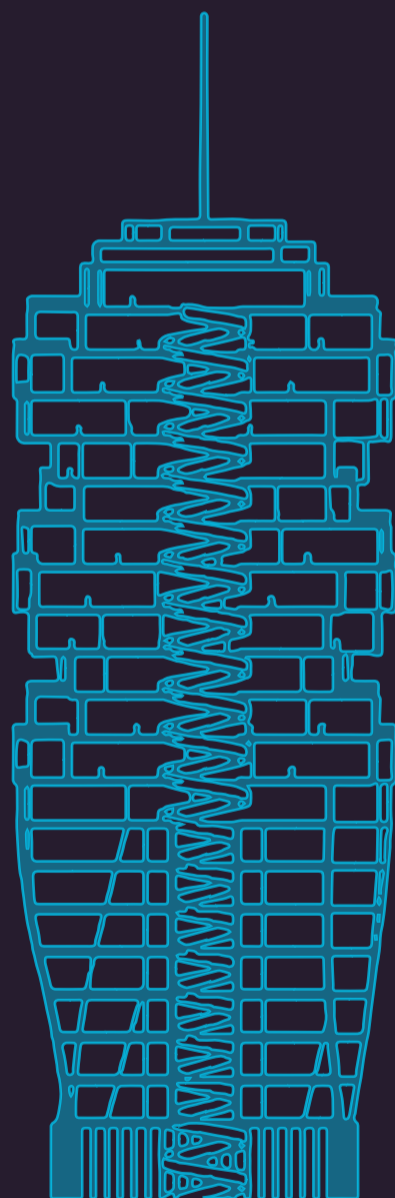

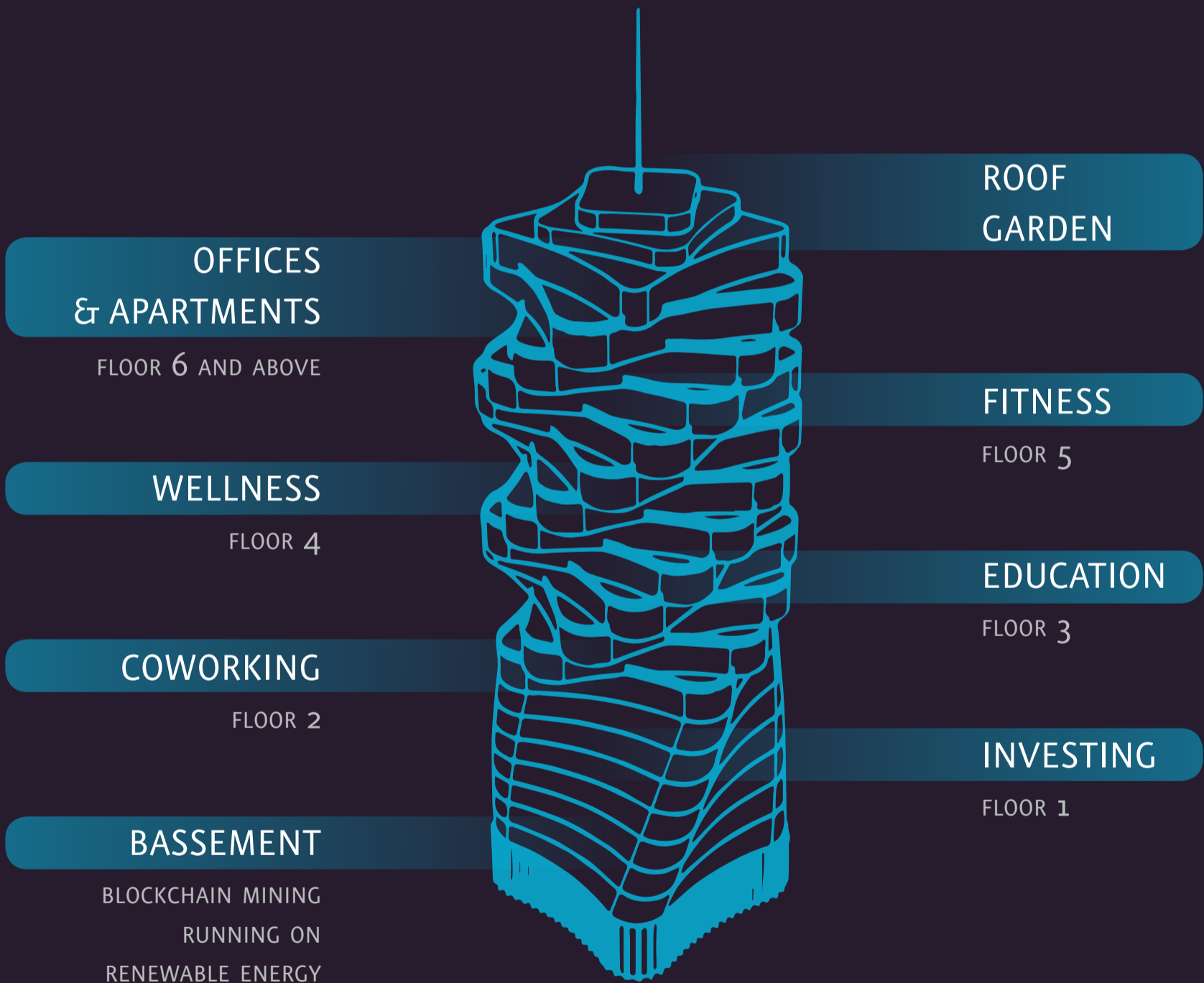
